C2.1: PRICING INSTRUCTIONS

ERRATUM

- C2.1.1 For the purposes of the pricing, the AG Rates as published must be used.
- C2.1.2 The rates, prices and sums tendered shall include full compensation for all overheads, profits, incidentals, mandatory taxes (other than Value Added Tax), for executing the work activities, for accommodation, travelling time and expenses, allowance for delays due to inclement weather, data capturing, all liaison required, project management, insurances, for all risk, obligations and responsibilities.

Value Added Tax (VAT) shall be excluded from the tendered rates, sums and prices.

C2.1.3 Disbursements: Disbursements shall only be used, in whole or in part, in accordance with the Employer's instructions. The total sum paid to the Service Provider shall include only such amounts, for the work, supplies or services to which the disbursement relates, as the Employer shall have instructed.
